

FREE LEGAL ADVICE SCHEME ON HKU CAMPUS

The Faculty of Law of The University of Hong Kong, has introduced on a pilot basis a Free Legal Advice Scheme on campus under the Duty Lawyer Service. The objective of the Scheme is two-fold: (1) to offer members of the University or the public having legal problems preliminary advice as to their legal position; and (2) to allow our law students taking the Clinical Legal Education Course an opportunity to develop their lawyering skills and to promote pro bono culture.

Preliminary legal advice will be given by our teaching staff who are qualified lawyers, with the assistance of our law students. Any person wishes to seek free legal advice from the Scheme must first attend an interview to be conducted by our law students, who will take down the detailed background of the case and obtain relevant documents. Our law students will **NOT** give any legal advice at the interview session. Advice will be given by our qualified teaching staff at an Advice Session to be scheduled normally within two or three weeks. We however reserve our right not to provide service if we do not have any spare capacity, or the case is not of sufficient educational value in our view, or for other good reasons. Each advice session will normally be allocated 20 to 30 minutes.

How to Apply

Case intake for the Scheme will commence on Tuesday, 19 January 2010 and end on Thursday 25 March 2010. Interview sessions will be conducted at our Clinical Legal Education Service at 5/F, TT Tsui Building during the following timeslots (around 20 to 30 minutes per interview):

香港大學法律學院與當值律師服務計劃合作，在港大校園展開一項免費法律諮詢先導計劃，旨在（一）為面對法律問題的大學教員、學生、或公眾人士提供初步的法律意見；（二）透過處理真實案件，加強法律學生處理案件的經驗和技巧，及推廣義務專業服務的文化。欲尋求法律諮詢的人士，須先安排與法律學生初步會面，學生將會記錄個案背景、情節，和索取有關文件，期間並不會提供任何法律意見。會面後一般可在兩至三週內，獲具執業資格的導師接見，並給予法律意見，學生則從旁協助。由於資源所限，我們只能集中處理少量具教育價值的案件，並保留不接受任何案件之權利。每節法律諮詢約 20 至 30 分鐘。
