REPORT OF THE EXECUTIVE COMMITTEE FOR THE PERIOD

FROM DECEMBER 2007 TO NOVEMBER 2008

During the report period, Executive Committee of the Association has held 6 meetings. Below is a brief account of the work done and activities during the period.

The University

- 1. On 6 December 2007, the President attended the Alumni Leaders' Gathering with the Vice-chancellor Professor Lap-Chee Tsui and the Pro Vice-chancellor Professor John Malpas, at the Hong Kong Football Club, for an update on the university developments including 18th and beyond, and Centennial Campus 2012.
- 2. On 27 February 2008, the President attended the HKU Centennial Campus Kick-Off Ceremony, which was held on site to the west of the current Main Campus.

The Faculty

- 1. On 27 December 2007, the President attended a meeting of the Board of the Faculty in Senate Room, 10/F Knowles Building, during which a presentation was made by Professor John Malpas, Pro Vice-chancellor of the University and Mr. Lam Wo Hei, Director of Wong & Ouyang and architect in charge of the Centennial Campus project. During the meeting, the President informed the Board *inter alia* that the Faculty's alumni wished that the University and the Project Team could take into account the strong sentiment that the law building should befit the dignity of the law discipline and serve as a symbol of the importance of the rule of law in Hong Kong.
- 2. On 19 March 2008, the President attended the Dedication Ceremony held at the University Lodge and thanked Dr Cheng Yu-Tung for his support and donation to the Faculty of Law and the University.
- 3. On 6 June 2008, the President attended the Graduation Reception of the Master of Common Law 2008 held at the Eilot Room, KK Leung Building.
- 4. On 1 November 2008, the President attended the 2008 Graduation Ceremony for Bachelor of Laws Graduates held at Loke Yew Hall and participated in the Procession.

The Association

- 1. Informal Gatherings with Alumni
 - On 3 May 2008, an Evening Drinks Party was held at the China Tee Club. 35 members, alumni and previous mentors of the Law Mentorship Programme joined.

It was an excellent opportunity for junior members of the legal profession to get to know senior members of the legal profession.

- Current members of the Executive Committee attended a dinner organized by Professor Johannes Chan SC (Hon), Dean of the Faculty of Law, on 23 June 2008.

2. Talk for Current Students

The talk "First Day in Legal Practice" was held on 8 April 2008. The President as Moderator, Ms Wendy Chow, Mr Erik Shum, Mr Henry Ma and Mr William Liu generously shared their experience of their first day at work with 21 law students.

3. Law Mentorship Programme

The Law Mentorship Programme started on 24 September 2008 with a Briefing Session for the students. A total of 208 students attended the Briefing Session. The President, joined the briefing session with 4 previous mentors and mentees, to share their experience and thoughts about the Programme. The total number of mentees selected is 181. Mentorship dinners were then held on the evenings of the 22 and 23 October 2008 respectively. The Public Relations Officer's report on the Mentorship Programme was received on 3 November 2008. Report on the Mentorship Programme 2008-2009

1. Introduction

The Law Mentorship Programme 2008-2009 is the sixth mentorship programme since its first launch in October 2002. The Law Mentorship Programme ("the Programme") is jointly organized by the Faculty of Law and The University of Hong Kong Law Alumni Association ("the Law Alumni Association"). It aims to provide law students with the opportunity to meet legal practitioners and judges and to enhance their educational, social and personal growth through a supportive relationship with their mentors. Over the years, the Law Alumni Association has provided tremendous support and assistance in the organization and running of the Programme, particularly in engaging the support of members of the profession and the Judiciary, many of whom are our alumni.

For the academic year 2008-2009, 85 mentors and 181 mentees participated in the Programme. To initiate the first contact between the mentors and their mentees, the Faculty and the Law Alumni Association organized the Mentorship Dinners on 22 October and 23 October. It is expected that the mentees will take the initiative to organize at least one more gathering before end of March 2009. It is also hoped that apart from these two gatherings, individual mentees and their mentors can develop further relationship through other communications or meetings.

2. Purposes of the programme

- To provide an opportunity for law students to learn more about the careers in the legal profession
- To enhance personal development of students through interaction with their mentors
- To enable members of the legal profession to understand more about the life of law students nowadays

3. Recruitment

Recruitment of Mentees

Invitation was sent to all law undergraduate students (except first year students) and all full-time PCLL students on 18 September.

The total number of applicants for the academic year 2008-2009 is 262. Out of these applications, 208 students had attended the Briefing Session on 24 September. Priority was given to (i) PCLL and final-year law students, (ii) previously applied but rejected students, and (iii) fresh applicants and returning mentees. The total number of mentees selected is 181.

Recruitment of Mentors

Invitations were sent on 16 September 2008 to, (i) previous mentors, (ii) alumni with 10+ years of experience, who had indicated their interests in joining the Programme, and (iii)

HKULAA members with 10+ years of experience but who had not joined the Programme before. By mid October 2008, 81 mentors have confirmed their participation. And 4 mentors joined in the week of 20 October 2008.

4. The Briefing Session

A briefing session on the Programme for interested students was held on 24 September 2008 in T1 of the Meng Wah Complex. The briefing session started at 6:30 pm and Dr. Richard Wu was the MC of the session. Ms Lucy Yen, President of the Law Alumni Association, joined the briefing session with following mentors and mentees, to share their experience and thoughts about the Programme. The session was well received by the students. Our sincere thanks to the following speakers for their sharing at the session:

The briefing session concluded at about 7:30 pm and most of the students stayed for the whole session.

5. The Mentorship Dinners

Dates and Venues

2 nights were scheduled for the Mentorship Dinners: 22 October and 23 October at the Loke Yew Hall, *Joseph's* was engaged to provide the catering services.

Pre-dinner briefing to Mentors

On each of the two nights, Mentors first gathered in MG07, Main Building for a pre-dinner briefing session. The Dean, Professor Johannes Chan, and Professor Michael Wilkinson took turns to brief the mentors attending the mentorship dinners. The briefing to Mentors covered the mainly the following points:-

- Acknowledging support of the Mentors
- The objectives of the Programme
- The pairing arrangement
- Possible follow-up activities
- The role of students in initiating subsequent gatherings

Pre-dinner briefing to Mentees

Mr Eric Cheung and Ms Karen Kong took turns to brief our students on the two nights. The briefing to mentees mainly covered the Dos and Don'ts on the part of mentees, including matters in relation to the dinner, follow-up activities and communication with mentors etc.

An email attaching an evaluation form will be sent to all mentees in late November 2008 requesting the representative of each group to complete and return the interim evaluation form to the Faculty of Law before 15 December 2008.

7. Suggestions on improvement

Invitation to Mentors

This year 85 members of the profession joined the Programme. Among the 18 new mentors, 12 of them were alumni; and the rest were introduced by their friends or colleagues; or indicated their interests through their firms (*Deacons* and *Simmons & Simmons* kindly circulated the invitation to their partners). Exco members may wish to invite other law firms/ chambers to take part in this Programme by circulating the invitation in the future.


