REPORT OF THE EXECUTIVE COMMITTEE FOR THE PERIOD  
FROM FEBRUARY 2023 TO MARCH 2024

Dear Members,

This year has been a fruitful year for The University of Hong Kong Law Alumni Association (“**HKULAA**”) during which we have planned and executed a diverse range of events and activities for our members and students with the end of the pandemic challenges and supported the celebration of the 55<sup>th</sup> Anniversary of the HKU Faculty of Law (“**Faculty**”) in the first few months of 2024.

**Law Mentorship Programme 2023-2024**

Thanks to the alumni's support, we have recruited 57 mentors, and 98 mentees were enrolled to the Programme. The Briefing Session and the First Gathering of the Programme were held physically on 15 September 2023 and 14 November 2023 respectively. The Dinner Gathering was successfully held at The Park Lane Hong Kong, A Pullman Hotel on 22 February 2024.

**Alumni Drinks Gathering**

An alumni drinks gathering was successfully organized on 15 May 2023 at the Club Lusitano (24/F, 16 Ice House Street, Central). The gathering was attended by teachers (Professors Rick Glofcheski, Ms. Julianne Jen and Ms. Charmaine Yip); Exco members and 33 alumni. Feedback from participants has been positive and they have expressed their delight at the warm and energetic atmosphere at the gathering: The alumni drinks gathering provided a wonderful opportunity for alumni to reconnect, network and reminisce about their law school experience.

**Career sharing session**

The Association organized a career sharing session via Zoom “Ask me a question” on 23 September 2023. It was hosted by Ms. Charmaine Yip and questions were collected from registrants in advance. All Exco Members

joined to share their career and life experiences and 30 students attended the sharing session.

#### ***(1) Launch Party of the Iconic Tramcar of the Faculty***

Featuring law alumni soccer matches, track challenges and game booths, the event was attended by more than 200 alumni, friends and families and received positive feedback.
