## **A Third Option: Going it Alone**

It is possible to go on exchange to a university of your choice entirely on your own initiative, self funded etc.

You would still need permission to defer your studies or to transfer credits in accordance with an approved study plan but it can be done.

And I, as Director of Student Exchange (Outgoing) would be happy to help you do this.

# The Basic Idea

HKU & Law Faculty  
have entered into exchange agreements  
with a range of other university partners.

## If You Go Through One of Our Two Exchange Programmes:

1. HKU or the Faculty does the liaison with the host school **although** you have to fill out & send the formal application yourself;
2. you only have to pay HKU tuition fees;
3. you can be sure of being able to transfer your credits; and
4. you can receive financial and other assistance from us.

## What if I Want to Apply to the UNIVERSITY Scheme?

1. You will have a different range of choices
2. You could go in your second LLB undergraduate year but difficult for law
3. You would be competing with students from all HKU faculties
4. You should fill in the OISE form on line only

## What if I am Only Interested in the Faculty Exchange Scheme?

1. Fill in the faculty form only
2. Get priority for faculty places
3. Choose 3-5 options, ranked in priority.
4. You can choose to go to:
  - one place for one semester
  - one place for a full year if host school permits
  - two places in one year
    - (i) civil law country + common law country
    - (ii) mainland China + any other country



# When Should I Apply for BOTH Exchange Schemes?

You should apply for both schemes

if

you wish to apply for one of the institutions not listed on the Faculty of Law exchange website and you also wish to apply for Faculty of Law institutions (for instances: U of Nottingham or U of Southampton).

**Note:** If you want to apply for an exchange place at King's College London or University of Bristol, you only have to apply through the Faculty Student Exchange Programme.

## If You Want to Apply to Both Schemes

You must:

(i) Fill in and submit **BOTH** forms:

- the OISE form on line and
- the Faculty of Law form in hard copy.

(ii) Indicate on the Faculty of Law form that you have applied for HKU as well.

# Transfer of Credits

‘Going on Exchange’  
**does NOT** require a deferral of your studies.

You can transfer the credits you earn at the partner institution to your HKU LLB degree.

With reasonable planning, most students can go on exchange **AND** still graduate with their classmates!

## How many credits can I transfer?

A standard HKU LLB students takes 30 credits (5 courses) per semester, 60 credits (10 courses) per year, some mixed degree students a few more.

Most of our partner universities have similar expectations but some believe in fewer courses with more reading per course, some go for more.

**A FULL LOAD** at any partner university will be transferred as a full load at HKU- somehow.

## Do the Grades I Earn on Exchange Count Towards My CGPA?

**NO** - grades earned on exchange neither help nor hurt your CGPA.

1. If you want to improve your CGPA for whatever reason, you need to think very carefully about your exchange options and courses.
2. You will have a transcript of your exchange results to show the PCLL admissions and future employers. If you do well, this could help you.

# Which Courses Can I Transfer?

## LLB Compulsory Courses -

1. All the different forms of LLB offered here at HKU require students to have passed a number of compulsory courses before they can be awarded the degree.
2. For the purposes of the LLB alone, it is possible to satisfy these compulsory requirements by taking approved equivalent courses during your exchange **OR** change your order of study (ie. satisfy the compulsory requirements before or after exchange).

**BUT** some courses are more difficult to match than others (for instance: Civil & Criminal Procedure courses)

**AND**

Some jurisdictions are less like Hong Kong than others so that matching courses is more difficult there.

Furthermore:

If you intend to practice law in Hong Kong, it makes sense to study most of the core subjects of Hong Kong law **HERE**.

and

Spending your valuable overseas experience only studying foreign equivalents of our compulsory core subjects or PCLL prerequisites – may not be making the best use of your opportunity.

Apply to Director, Student Exchange (Outgoing)  
(include course descriptions, unit or credit weighting, contact hours, assessment, content information)

Specific approval of Head of Department (Law) required for:

- Acceptance as satisfying Directed Research Course
- Acceptance as part of Specialisation
- deferral of compulsory mootings
- over or under loading at HKU or exchange institution

# PCLL Admission Prerequisites

If you do not study these three subjects in HK,  
you will need to do  
**TOP UP CONVERSION EXAMINATIONS.**

1. HK Legal System
2. HK Constitutional Law
3. Land Law III (HK Conveyancing)

**PLAN TO STUDY THESE COURSES AT HKU!**

IN ADDITION, you must demonstrate competence in the following core subjects:

1. Contract
2. Tort
3. Equity & Trusts
4. Criminal Law
5. Commercial Law
6. Business Associations
7. Civil Procedure
8. Criminal Procedure
9. Evidence

Applicants to the PCLL with an HKU LLB of whatever kind may demonstrate competence in these courses by:-

1. passing the relevant course as part of their HKU LLB, whether as core course or law option; or
2. passing an APPROVED equivalent course while on exchange (obtain prior approval of your study plan and a Certificate of Completion after your return); or
3. passing a conversion examination where offered

## Where Can You Find Equivalents for These Courses?

- Civil Procedure, Criminal Procedure and tend to be relatively jurisdiction specific.
- It's a good idea to plan to do these courses during your LLB degree here or, if you are confident, as a conversion examination.

# Common Law Jurisdictions

- **Equity and Trusts:** difficult in USA and Canada (some combinations of courses accepted)
- **Business Associations:** missing partnership
- **Commercial Law:** missing agency and mortgages
- **Administrative Law:** often not offered as separate course and / or too much human rights content
- Courses that are compulsory for students of the host jurisdiction, like Criminal Law, are not always available to exchange students and may in any case be too short.

## **Change in Policy with Respect to Pass / Fail Course**

- In past years, the Department has had a policy of not transferring credits obtained for pass / fail courses. Only courses with letter grades were accepted
- Beginning this year, that policy has been changed. At least for course that will be transferred only as law or non-law options, pass / fail assessment is now acceptable.

# Civil Law Jurisdictions

## PRC Universities

- Excellent for Chinese law and Putonghua
- Courses cannot satisfy any of PCLL core.

## European Universities

- Excellent for really interesting law options,  
a possibility for Legal Theory and DRC
- Courses cannot satisfy any of PCLL core.

# Can I Go on Exchange and Still Fulfill My Specialisation Requirements?

**YES!** We approve each application personally though so allow time

**Chinese Law:** PRC courses but courses in other schools will be considered.

**Commercial, Corporate and Financial Law AND International Trade and Economic Law:**

Courses offered at both common law and civil law institutions may be accepted – name or content match to HKU course not necessarily required.

## What If I Want to Do a Minor?

- LLB regulations permit LLB students to take not more than 48 non-law credits, enough for a minor in another discipline.
- We are happy for you to take non law subjects at your host University for this purpose **BUT**
  1. You need to check with the host University - they may not allow law students to take non-law credits;  
&
  2. We need to consult relevant HKU department re transfer of non-law credits – so allow time.

## **LLB(BBA) and LLB(G&L) Students Non Law Subjects**

We are happy for our students to fulfill some of these non-law requirements at partner universities **IF** partner universities are willing **AND** relevant HKU departments approve the courses for credit transfer.

### **But consider:**

If you pass a full load of law courses at the partner university, that will be transferred to HKU LLB as 60 credits. Even if you have to do all the non law in Year 5, the overload is minimal.

## Am I Qualified to Apply?

- CGPA of 2.8 for worldwide exchange scheme, CGPA of 3 for scholarship
- CGPA of 2.8 under Faculty exchange scheme, although some specific exchange partners require CGPA 3.0 or above
- LLB students usually go in 3<sup>rd</sup> or 4<sup>th</sup> year
- LLB(BBA), LLB(G&L) in 4<sup>th</sup> or 5<sup>th</sup> year
- LLB(Civ-Eng) in 5<sup>th</sup> year
- Personality: willing to try new things, courteous to others, tolerant of difference.

## What to Submit

1. Completed application form
2. Official copies of academic transcripts
3. Official class ranking (only LLB students are required to submit their Ranking)
4. CV and Personal letter stating reasons for applying exchange
5. TOEFL or IELTS test result (this is optional BUT your TOEFL/IELTS result may be helpful for the host university to consider your application)

# Golden Rule

**ONLY**

apply for any institution  
you are prepared to go to  
- even as your 5th choice.

# How to Choose?

1. Do your research about the universities
2.  $\text{CGPA} \geq 3.0$ , apply according to preference only
3.  $\text{CGPA} \leq 3.0$ , be realistic & flexible (not KCL, UCL, Nottingham, Warwick, Duke, Cornell and USC (unless very close))
