**AWARDS AND DISTINCTIONS**

1. Awarded the inaugural Rosie Young 90 Medal for Outstanding Young Woman Scholar in 2021. Two medals are awarded by the University of Hong Kong each

year, with one reserved for scholars from the medical discipline. I was selected as the first recipient of the medal from all non-medical disciplines.

2. Awarded the 2017-2018 Outstanding Young Researcher Award by the University of Hong Kong. This award is granted in recognition of scholars in the University below the age of 40 who have produced 'extremely high quality research'.
3. Paper on 'Proportionality and Invariable Baseline Intensity of Review' awarded the 2012 Best Paper Prize by the Society of Legal Scholars from eligible entries amongst some 270 papers presented at the Society's annual conference. The judges described the paper as having made 'an original, well-argued and important contribution to scholarship' in the field. The Society is 'the oldest as well as the largest learned society in the field of law'.
4. In addition to obtaining the competitive Early Career Scheme grant of the Hong Kong Research Grants Council, my grant proposal on 'Judicial deference in constitutional rights adjudication' was also awarded the 2013 Early Career Award by the same body in recognition of the excellent quality of the proposal. Only 5% of top junior scholars are shortlisted for this award.
5. Article on 'From Legal Pluralism to Dual State: Evolution of the Relationship Between the Chinese and Hong Kong Legal Orders' awarded the 2023 Faculty Research Output Prize by the University of Hong Kong.
