The Job Interview Workshop organized by HKULAA was held on Monday, 24 September 2007. It was conducted in three parts. Ms Cissy Leung, Exco member of the HKULAA, first shared with students on the preparation required for an interview, and the “dos” and “don’ts” for a job interview; then two individual mock interviews were conducted by three experienced alumni, Ms Au Miu Po (LLB 1973), Her Honour Judge Mimmie Chan (LLB 1980, PCLL 1981) and Mr Simon Ip Shing Hing (LLB 1978, PCLL 1979), with law students seeking to apply to the hypothetical employers, Woo, Kwan, Lee & Lo, for trainee position. A group interview of three law students was then conducted. Finally practical feedbacks from the Ms Cissy Leung and the guest interviewers on the mock interviews were given and there was a Q & A session that welcomed questions from all participants.
