This year has been a fruitful year for The University of Hong Kong Law Alumni Association (the “**Association**”) during which we have planned and executed a diverse range of events and activities for our members and students and supported the celebration of the 55th Anniversary of the HKU Faculty of Law (the “**Faculty**”).

HKU Law Alumni Choir Concert “*Popera*”

The HKU Law Alumni Choir Concert, co-organised by the Association and the Faculty, was titled “*Popera*” and took place on 15th June 2024 at the HKU Grand Hall as part of the celebrations for the Faculty’s 55th Anniversary. The event featured a full choir and accompanying orchestra, with both vocalists and instrumentalists comprised of alumni and current students of the Faculty. Under the guidance of Choir Chairman and Conductor, Mr. Jeffrey Sham, the choir and orchestra captivated the audience with their operatic interpretations of popular songs.
