The University of Hong Kong Faculty of Law

From a teaching department of three teachers and 40 students in 1969 to a Faculty today with about 2,700 students and over 80 full time academic staff from about 17 jurisdictions, the Faculty of Law has been the training ground of many distinguished legal minds. Generations of lawyers who graduated from the Faculty now form the backbone of the legal profession, and protect the Rule of Law in Hong Kong, which is crucial to the success of the territory.

The founding Bachelor of Laws (LLB) programme, together with the integrated double-degree programmes and dual degree programmes in law, are ranked among the top undergraduate curricula at HKU. So is the highly competitive Juris Doctor (JD) programme introduced in 2009. The Master of Laws (LLM) programmes have since 1989 offered specialist, cutting-edge law courses to meet the demands of a rapidly changing global environment. The Master of Common Law (MCL) programme has trained more than 350 mainland Chinese judges and government officials in common law since 1997.

In recent years, the Faculty has partnered with some of the most eminent law schools in the world, including double degree programmes with University of British Columbia, University of Pennsylvania, University College London, University of Zurich, Peking University and University of California, Berkeley; and research projects and joint conferences with University College London, University of Cambridge, University of New South Wales and National University of Singapore.

The Faculty is committed to academic and professional excellence in meeting the challenges of a rapidly changing environment. While the Faculty has gone a long way from its inception in 1969, it continues its efforts in international outreach, in strengthening the ties with Mainland China, and in enhancing the quality of legal education with a view to train not just good lawyers but also leaders who have a passion to serve, wherever they are.

In 2012, the Faculty moved to the Centennial Campus, and has the privilege of a new home named after Dr Cheng Yu Tung. Our eleven-floor building befits the importance of our independent legal system, which is the cornerstone of Hong Kong's continued prosperity.

These programmes are designed to cultivate legal thinkers who are not only grounded in doctrine but also equipped to lead across sectors and borders. Single Law Degree Programme (4 Years)

6406 Bachelor of Laws [LLB]

The four-year LLB programme is the first local university qualification to be recognised for admission to legal practice in Hong Kong. It offers a range of distinctive features designed to ensure the competitiveness of our graduates, including:

- A solid foundation in legal knowledge, transferable critical and analytical skills, and broadening of intellectual horizons:
- Systematic honing of professional skills such as critical thinking, analytical and problem solving skills, research and writing skills, and bilingual language proficiency; and
- Integrated experiential learning and capstone experience through an integrated sequence of legal research and writing, mooting, internship and clinical legal education.

Integrated Double-Degree Programmes (5 Years)

6808 Bachelor of Business Administration (Law) and Bachelor of Laws [BBA(Law)&LLB]

Jointly offered by the Faculty of Law and the HKU Business School, the BBA(Law)&LLB integrated double-degree programme blends two strategic disciplines into a single programme for the bright and highly motivated. It is an excellent choice for students seeking a broader education with parallel concentration on legal and business studies. Graduates of the programme will be awarded two degrees – BBA(Law) by the HKU Business School, and LLB by the Faculty of Law. The LLB degree is a basic requirement needed to pursue a legal career. After successful completion of the LLB programme, students may apply for admission to the Postgraduate Certificate in Laws (PCLL) programme provided that they meet the relevant admission requirements.



Integrated Double-Degree Programmes (5 Years)

6078 Bachelor of Arts and Bachelor of Laws [BA&LLB]

Jointly offered by the Faculty of Law and the Faculty of Arts, the BA&LLB integrated double-degree programme draws on the complementary strengths of the two Faculties where questions of textual interpretation are paramount. Law and literature have intertwined institutional histories: the study of rhetoric was originally designed to develop the oratory skills of lawyers in the courts, and the works of literary authors such as William Shakespeare and Charles Dickens can be interpreted as responses to contemporary legal developments. Moreover, both lawyers and literary critics engage closely with language, and law schools and departments of literature are sites at which questions of rhetoric, interpretation and meaning receive the most intense scrutiny. The programme aims to develop competence in both legal and literary analysis, encourage interdisciplinary thinking, and enrich students' sense of human and social values. It also prepares them for a variety of careers in the law, the humanities, and beyond.

6858 Bachelor of Science and Bachelor of Laws [BSc&LLB]

Jointly offered by the Faculty of Law and the Faculty of Science, the BSc&LLB integrated double-degree programme is designed to cater for the increasing demand for talented graduates with both science and law training to assume leadership roles relating to innovation and policy-making in today's STEM-driven society, including the Greater Bay Area and globally. It aims to fill the current knowledge and education gap by providing academic training for legal professionals with expertise in science and scientists with the knowledge to understand complex legal and ethical processes associated with their research, innovation and inventions. The programme will equip students with academic and interdisciplinary knowledge, alongside analytical and evaluation skills, in both law and science. Graduates will be ready and able to tackle challenges in STEM-driven regulatory affairs and intellectual property protection.

Dual Degree Programmes (4 or 5 Years)

In addition to our 4-year LLB, students may also consider choosing to study the four-year and five-year Dual Degree Programmes in Law jointly offered with University College London (UCL) and Peking University (PKU) respectively.

HKU-UCL Dual Degree Programme in Law

The HKU-UCL Dual Degree Programme in Law was jointly launched by HKU and UCL in September 2016. The Programme enables students to study in two of the world's key global financial centers, London and Hong Kong, and to gain insight into the legal systems of two important common law jurisdictions — one as the origin of the common law with exposure and expertise in European Union law, and the other in a central hub of legal education in Asia. Students will spend the first two years at UCL and the following two years at HKU.

While at UCL, students will be required to take a compulsory extracurricular placement in the UCL Center for Access to Justice where students will have the opportunity to interact with legal professionals in providing legal assistance to the local community. During the last two years of study at HKU, they may also have an opportunity to study a course in an eminent university in Mainland China by way of intensive teaching, and broaden their horizons by participating in a vocational internship. Upon successful completion of the whole programme, separate Bachelor of Laws (LLB) degrees will be awarded by these two prestigious and highly ranked law schools.

The dual degree prepares you not just to practice law, but to understand it from a comparative, international, and interdisciplinary lens, which is essential in today's globalised legal landscape.



HKU-PKU Dual Degree Programme in Law

The HKU-PKU Dual Degree Programme in Law was jointly launched by HKU and PKU in September 2019. The programme integrates the strengths of two leading law schools in Hong Kong and Mainland China, and allows students to develop a robust understanding of two different, associated legal systems. Students will spend the first 2.5 years in HKU learning the fundamental legal concepts on common law jurisdictions, followed by another 2.5 years at PKU learning about the civil law system in Mainland China. Students will be able to work with legal professionals in Mainland China in their graduation internships and broaden their horizons. Graduates who have completed this programme will obtain two LLBs from both leading law schools, and open their paths to legal qualifications in both jurisdictions.

Joint Education Programme with UBC

In 2009, HKU and the University of British Columbia (UBC) established a joint legal education programme that allows current LLB students to pursue professional qualification studies in both Hong Kong and British Columbia, Canada. Under this joint LLB-JD programme, an LLB student will be able to complete 2 degrees in two jurisdictions in 5 years. Subject to application, eligible law students may be nominated for admission after having successfully completed the third year of study at HKU.

Pathway Programmes to an LLM with our Strategic Partners

In light of the rapid social, cultural, technological, economic, legal and political changes driving changes in norms and expectations about how university graduates should contribute to society both locally and globally, the Faculty has provided a wider range of options to our law students by way of pathway programmes with strategic partners around the globe. Subject to applications, LLB students may be given the opportunity to obtain an LLB with HKU and an LLM with our partner institutions, such as King's College London, University of New South Wales and University of California, Berkeley, in four or 4.5 academic years under respective agreements.

HKU Law Clinical Legal Education

HKU Law's Clinical Legal Education (CLE) programme is Hong Kong's first and only live-client legal education initiative, offering students a rare opportunity to engage directly with real legal problems while serving the community. Launched in 2010, the programme has become a cornerstone of experiential learning at HKU Law — blending academic rigor with professional practice.

Through the CLE programme, I had the opportunity to interact directly with lay clients in real cases for the first time. Under the guidance of volunteer lawyers, I honed my research and drafting skills while gaining valuable insights from their legal advice. The first-hand experience in bringing actual impact to people's lives by applying legal knowledge truly hits different compared to textbook learning.





Explore CLE

Outside of Class Action

Students enrolled in CLE work in pairs to:

- Conduct initial interviews with lay clients
- Draft case summaries and perform legal research
- Attend advice sessions with qualified solicitors and barristers
- Record and summarise legal advice for review and archival

Each case is selected for its educational value, and students are mentored by faculty and volunteer lawyers throughout the process. The programme covers a wide range of legal issues, including:

- Contract and business disputes
- Divorce and custody
- Employment and consumer rights
- Criminal matters and judicial review
- Property and inheritance claims
- Intellectual property and defamation

Where Legal Education Meets Social Impact

CLE goes beyond the classroom — it's a platform for public service, legal empowerment, and professional development. Students gain hands-on experience in client interviewing, legal analysis, and ethical practice, while clients receive free preliminary legal advice and, in some cases, assistance with legal aid applications. The programme fosters a strong pro bono ethos and is widely recognised for its impact on legal education and access to justice.

Mooting at HKU Law

The Art of Advocacy

Mooting is a cornerstone of legal education at HKU Law. Through simulated court proceedings, students develop the ability to analyse complex legal issues, construct persuasive arguments, and present with clarity and conviction before panels of judges and practitioners.

A Professional Training Ground

HKU Law's internal mooting programme stands as one of the most intellectually demanding and professionally rewarding experiences for upper-year students. Organised annually by the Mooting Committee, this compulsory programme is designed to cultivate courtroom advocacy, legal reasoning, and public speaking at the highest level.

Moots are held at the High Court of Hong Kong or on campus, with panels comprising legal practitioners and academic staff. From this competitive field, sixteen outstanding mooters are selected for the semi-finals, judged by senior members of the legal profession and the judiciary.

The top four advance to the Grand Final — a prestigious event where finalists compete for:

- The Hong Kong Bar Association Cup (Best Mooting Team)
- The Deacons Cup (Best Individual Mooter)

Established in 2002, the student-led non-profit Advocacy and Mooting Society (AMS) plays a vital role in:

- · Fostering students' interest in mooting
- Acquiring a better understanding of the role of advocacy in legal practice
- Providing students with opportunities to sharpen their skills through receiving feedback from experienced practitioners



Non-JUPAS

Students who are 1) local students with an international qualification or pending international qualification other than the HKDSE, or 2) non-local students with an international qualification or other national examination qualifications other than Mainland China's National Joint College Entrance Examination (NJCEE) or GaoKao, are welcome to apply via HKU's international or non-JUPAS admissions scheme.

Application Procedures

Non-JUPAS applications should be submitted via HKU online application system by noon of 26 November 2025 (Hong Kong time) for first-round evaluation. Applications received after noon (HKT) on this date will be considered on a rolling basis. Interviews will be extended on a case-by-case basis. Optional interviews will be arranged if necessary.

Admissions Requirements

Due to the complex combination of education background of applicants and variations across education systems, each application will be assessed individually on its own merits. Non-JUPAS applicants are strongly advised to refer to the standards and requirements outlined on HKU Admissions Office website before submitting an application. Admissions are conducted on a competitive basis. The expected lower boundary for admissions listed on HKU Admissions Office website serves as a general reference only. Meeting the expected lower boundary does not guarantee admission to the programme. Actual admission scores or grades will depend on the overall quality of applications received in a given admissions cycle.

Offers of Admissions

Offer results will be released from December onwards. All offers are conditional upon applicants obtaining the required examination results for submission to the University. Application status will be updated in the HKU online application system once an admissions decision has been made. Applicants are advised to check their application status online regularly.

Dual Degree Admissions

Separate applications are required for the dual degree programmes, in addition to the applications submitted under the JUPAS or International/Non-JUPAS Admissions Scheme.
